### NOTIFICATION

No. 100/ARUN-LA/01/2016.—**WHEREAS**, the seat of Shri Gabriel Denwang Wangsu in the Legislative Assembly of the State of Arunachal Pradesh, elected from 58-Kanubari (ST) Assembly Constituency in the State, has become vacant on 1st October, 2015 by reason of his resignation and;

2. **WHEREAS**, a bye-election is to be held for the purpose of filling the vacancy so caused ;

3. **NOW, therefore**, in pursuance of Sections 150, 30 and 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby -

**(A) Calls upon** the said 58-Kanubari (ST) Assembly Constituency in the State of Arunachal Pradesh, to elect, before the 21st May, 2016 (Saturday) and in accordance with the provisions of the said Act and of the rules and orders made there under, a person, belonging to any of the Scheduled Tribes of the State, for the purpose of filling the said vacancy in the Legislative Assembly of the State.

**(B) appoints**, with respect to the said election,-

(a) the 29th April, 2016 (Friday), as the last date for making nominations;

(b) the 30th April, 2016 (Saturday), as the date for the scrutiny of nominations ;

(c) the 2nd May, 2016 (Monday), as the last date for the withdrawal of candidatures;

(d) the 16th May, 2016 (Monday), as the date on which a poll shall, if necessary, be taken ; and

(e) the 21st May, 2016 (Saturday), as the date before which the election shall be completed; and

**(C) fixes the hours from 07.00 A.M. to 04.00 P.M.**, as the hours during which the poll shall, if necessary, be taken on the date specified above, for the election.
