NOTIFICATION

No. 100/ARUN/02/2017. — **WHEREAS**, the seat of Shri Jomde Kena in the Legislative Assembly of the State of Arunachal Pradesh, elected from 28-Likabali (ST) Assembly Constituency in the State, has become vacant on 4th September, 2017 by reason of his death ; and

2. **WHEREAS**, a bye-election is to be held for the purpose of filling the vacancy so caused ;
3. **NOW, THEREFORE**, in pursuance of section 150, 30 and 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby -
 - (A) **Calls upon** the said 28-Likabali (ST) Assembly Constituency in the State of Arunachal Pradesh, to elect, before the 26th December, 2017 (Tuesday) and in accordance with the provisions of the said Act and of the rules and orders made thereunder, a person, belonging to any of the Scheduled Tribes of the State, for the purpose of filling the said vacancy in the Legislative Assembly of the State ;
 - (B) **appoints**, with respect to the said election, -
 - (a) the 27th November, 2017 (Monday), as the date of notification of bye-election.
 - (b) the 04th December, 2017 (Monday), as the last date for making nominations ;
 - (c) the 05th December, 2017 (Tuesday), as the date for the scrutiny of nominations ;
 - (d) the 07th December, 2017 (Thursday), as the last date for the withdrawal of candidatures ;
 - (e) the 21st December, 2017 (Thursday), as the date on which a poll shall, if necessary, be taken; and
 - (f) the 26th December, 2017 (Tuesday), as the date before which the election shall be completed ; **and**
 - (C) **fixes the hours from 07:00 A.M. to 04:00 P.M.**, as the hours during which the poll shall, if necessary, be taken on the date specified above for the election.
