PRESS RELEASE

The Election Commission of India has ordered Special Summary Revision of Electoral Rolls with reference to 01-01-2022 as the qualifying date, in all 60 assembly constituencies of the State. As per programme. Pre-Revision activities like Improvement in the health of Electoral Roll in a campaign mode for removal of DSEs, logical errors, checking of photo quality of elector will be started from 09.08.2021 to 31.10.2021. The citizen can verify their electoral details through "Voter Helpline app/nvsp.in website" or submitting a hard copy of filled up form through BLOs to EROs. BLO shall undertake a House to House verification about the information/details of un-enrolled citizens/dead/shifted electors collected through crowd sourcing as well as verification of the same from 09.8.2021 to 31.10.2021. Finalization of proposed restructuring of section/part boundaries location of polling stations and getting approval of list of polling stations etc. from the Commission by 31.10.2021.

The Draft publication of electoral roll will be made on 1.11.2021. The period for filing of claims & objection will be from 1.11.2021(Monday) to 30.11.2021(Tuesday). A Special Campaign will be organized on 13.11.2021(Saturday), 14.11.2021(Sunday), 20.11.2021(Saturday) and 21.11.2021(Sunday) in all the EROs/AEROs HQs and in some selected Polling Stations. Disposal of claims and objection by 20.12.2021(Monday). Final Publication of electoral rolls by 05.1.2022(Wednesday).



The Citizen those who are attained 18 Years Age as on 1.1.2022 as qualifying date can entitled to enroll their name in the electoral roll in Form 6, delete duplicate names/dead persons in Form 7, correction in the name in Form 8, Transposition of name within the Assembly Constituency in Form 8A and particulars of ID Cards in Form 001 to fill up through online service for voters “ www.nsvp.in “ or BLOs to their respective Assembly Constituency.


