PRESS NOTE

1. In accordance with the instructions of the Election Commission vide No. 23/2025-ERS (Vol. II) dated 14th May, 2026, the Special Intensive Revision (SIR) of Electoral Rolls, 2026 was undertaken in all districts of Arunachal Pradesh with effect from 5th June, 2026.

Final Photo Electoral Rolls of all 60 (Sixty) Assembly Constituencies of Arunachal Pradesh have been published today, the 22nd September, 2026 (Tuesday) by the concerned Electoral Registration Officers (EROs).

2. Electors are advised to verify/check their names in the Final Photo Electoral Rolls at the Offices of the Electoral Registration Officers, Assistant Electoral Registration Officers and the Booth Level Officers (BLOs). Digital copies of the Final Electoral Roll can also be downloaded from the Chief Electoral Officer's website: <https://ceoarunachal.nic.in>.

3. The total number of electors as on 2nd June, 2026 i.e. prior to draft publication was as under:

Enumeration Forms were generated and distributed to all **8,87,505** electors through BLOs. Of these, **7,18,046** forms were received back. The remaining **1,69,459**

electors whose forms were not returned were excluded from the Draft Electoral Roll. List of such electors whose Enumeration Forms were not received back was published indicating the probable cause: Absent, Shifted, Death, Duplicate & Others. The detailed breakup of the same is as follows:

4. The Draft Electoral Roll was published on 21st July, 2026 with a total of **7,18,046** numbers of electors. Electors' data as per the Draft Electoral Roll is as given below.

Out of the total 7,18,046 electors in the Draft Roll, **6,32,871** number of electors were either mapped as self or as progeny while **85,175** of electors were unmapped. The details of the mapping are as under:

5. Notices were served to all **85,175** numbers of unmapped electors for verification during the notice phase, i.e., from 21-07-2026 to 18-09-2026. In addition, notices were also served to **1,33,413** electors with logical discrepancies. A total of **2,18,588** notices were issued during the notice phase for verification of electors.

Decisions were taken by the concerned EROs/ AEROs with respect to the aforesaid unmapped electors and logical Discrepancies by conducting hearings and verifying the documents submitted by the electors & Undertaking submitted by the BLOs. Out of the total 7,18,046 electors in the Draft Roll, a total **28,899** number of electors

whose documents were found inadmissible/unsatisfactory during the hearing were marked as found ineligible, bypassing speaking orders.

6. A total of **18,598** Forms were received via online and offline mode during the period of claims and objections i.e. from 21-07-2026 to 20-08-2026.

7. A total of **8,803** numbers of electors have been included, and a total of **1,924** numbers of electors have been deleted from the Draft Electoral Roll. The total number of electors for the State of Arunachal Pradesh as per the Final Electoral Rolls, 2026 is as given below:

8. An appeal against the decision of the Electoral Registration Officer can be filed before the District Magistrate **within 15 days from the date of publication of Final Electoral Roll** under section 24(a) of the Representation of the People Act, 1950 read with Rule 27 of the Registration of the Electors Rules, 1960.

If dissatisfied with the first appeal decision, a second appeal may be preferred before the Chief Electoral Officer **within 30 days** of the District Magistrate's order as per section 24(b) of the Representation of the People Act, 1950 read with Rule 27 of the Registration of the Electors Rules, 1960.

9. The Final Electoral Roll of Special Summary Revision of the last part of Electoral Rolls relating to Service Voters with reference to 01-07-2026 as qualifying date is also published today i.e. 22nd September, 2026. The total number of Service Electors enrolled in the Final Electoral Rolls is **5,552**.

10. Electors seeking Inclusion (Form-6), Correction (Form-8), or Deletion (Form-7) in an Electoral Roll may submit applications via online or offline modes. For any election



related clarification, the public may contact State Contact Centre with the number 0360-1950 (Toll Free).

11. Soft copies of the Final Electoral Rolls (without photo) of each Assembly Constituencies were handed over to the authorized representative of recognized National and State Political Parties today during the meeting.

12. The Office of the Chief Electoral Officer extends its sincere appreciation to all Citizens, Political Parties, Civil Society Organizations, Media, and the entire election machinery—from District Election Officers & their teams to EROs, AEROs, BLOs—for their dedicated efforts in successfully completing the SIR process.



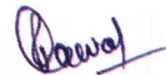
